




# **OUR OBJECTIVES**

## 2. President's Message

It is a privilege to lead FINACT during the last twelve months. I take this opportunity to thank FINACT member associations, past presidents, and Indian community more broadly for this opportunity and their support.

Although the risk of global pandemic isn't over yet, glad to see end of lockdowns, opening of international borders, arrival of international students and tourists. Thanks to the successful vaccination program, we were able to deliver our community work program in the last eight months.

This annual report summarises FINACT activities and achievements:

More than 50 volunteers contributed ~3865 hours of their time over the last 50 weeks to deliver FINACT activities. If valued at \$50/h, this equates to \$184K. It goes to show the value FINACT, and other associations give back to the community. I acknowledge and thank Sejal Patel, Rahul Ravindranathan, Praneeth Galla, Divya Ravikumar, Balinder Singh, Kanchan Vaikyl, Ravi Krish and Sunita Dhindsa for their significant contribution and unwavering support.

According to the latest census, number of people in the ACT of Indian ancestry has gone up from **14,483** in 2016 to **24,026** in 2021. Community work by FINACT and its member associations in welcoming new migrants, supporting them and providing them with cultural experience is an important contribution, which nicely complements the services provided by the ACT government. I'm glad to report that ACT government recognised our contribution in promoting diversity and inclusion across Canberra and ACT region through a multicultural excellence award in 2022.

The work of FINACT in fostering people to people connection is an important contribution in advancing the enduring friendship between Australia and India. Quad and interim free trade agreement will see further collaboration, increased trade, and cultural exchange between the two countries. ## 3. About FINACT

The Federation of Indian Association of the ACT (FINACT) Inc is an umbrella body that represents the interests of more than 24,000 Indian diaspora in and around ACT. Formed in 2011, FINACT consists of 31 member associations representing a diverse community consisting of regional, linguistic, youth, women, and senior citizens interests.

FINACT provides a unified voice for its member associations in fostering integration and promoting multicultural Australia. FINACT's objectives include promotion of multicultural Australia by sharing Indian culture and heritage, integration with the broader Australian society, cultivating mutual respect through increased social & cultural interaction, sports, and recreation. FINACT works with the Federal and ACT governments by providing constructive feedback and inputs to policy formulation on matters related to welfare, social and economic matters. FINACT's operating principles are – Coordination, Cooperation and Collaboration for the broader good.

### 4. FINACT Activities 2021-22

#### **COVID-19 Vaccination Promotion**

Uptake of COVID-19 vaccination was slow in the beginning because of concerns about side effects, scepticism and negative media reports. FINACT has partnered with the ACT Health Directorate's COVID-19 Response team, promoting vaccination to protect all Canberrans from the virus, making ACT the first jurisdiction in Australia to achieve high vaccination rates. This helped to curb the spread of the virus and eventually easing of COVID restrictions.

FINACT organised a video message - get vaccinated, follow health advice from the authorities, stay safe and save lives – in <u>multiple Indian languages</u>. This was well received, prompting community members to sign up for vaccination.

Only 35% of people in Gungahlin aged 15 and over were fully vaccinated as of August 2021 when we released our video, compared to 95% by November 2021. Thanks to the excellent work undertaken by the ACT Health Directorate and cooperation of Canberrans for supporting the vaccination program.

Mass vaccination and effectiveness of vaccines allowed the ACT government to relax COVID-19 pandemic restrictions. It is however, important to note that COVID-19 pandemic declaration is still active in Australia as of July 2022. Experts warn that variants of the virus can still wreak havoc.

# Promotion of COVID vaccination & support



Daily cases are going up significantly, exceeding the numbers seen during the peak period. For example, 1407 new cases were reported in ACT on 21 July, a significant increase over the last seven-day average. We recommend taking fourth dose which is now available to Canberrans. Please follow public health advice and Stay COVID smart.

#### Recognition of Covaxin (Bharat Biotech, India)

Recognition of Covaxin allowed stranded Australian citizens to return to Australia free of quarantine, including immediate family members who can reunite with family, which is great news. FINACT raised the issue with relevant authorities, and we are very pleased with the positive response and fast action from the Federal government. The Therapeutic Goods Administration (TGA) recognised Covaxin for the purpose of establishing a traveller's vaccination status.

FINACT welcomed the news and timely decision as it paved the way for Australians stranded in India to take advantage of the opening of international borders from 1 November 2021. This was also a positive news for international students to resume studies on campus, parents and other immediate family members to reunite with their family in Australia.

### COVID-19 Vaccination pop-up Clinic

FINACT collaborated with the ACT Health's COVID-19 Response Team to organise a COVID-19 vaccination pop-up clinic at the AusIndia Fair for individuals and families to receive their vaccination, open to all members, including international students, even without a Medicare card were eligible to get their free vaccine.

#### **COVID Promotion ACT Health**

Uptake of COVID-19 vaccination was slow in the beginning because of concerns about side effects, negative propaganda in the social media and fear of the unknown. ACT Health sought help from FINACT. We acted quickly by providing promotional material, published on the ACT Health Twitter account.

#### Opening of International Borders

FINACT welcomed the opening of international borders from 1 November 2021 ending two years of disruption and separation from near and dear ones. SBS and ABC 666 radio sought FINACT interviews seeking community view at the time.

#### AusIndia Fair 2022


AusIndia Fair is FINACT's flagship event that promotes harmony and brings communities together; celebrates Australia-India friendship and showcases India's rich cultural diversity. Most importantly this year it provided an opportunity to showcase creative artistic talents, after a two-year gap because of global pandemic, contributing to the post-COVID-19 'social recovery', and well-being of all participants.

This year's event held at Thoroughbred Park on 2 April 2022 was a huge success. More than 2000 people attended the event. Nearly 150 performers participated in the event from Indian, Sri Lankan, Tibetan, Australian and Brazilian backgrounds. Everyone immensely enjoyed in-person social interaction which has been missing in the last two years because of the global pandemic. FINACT received lots of compliments from the community and lots of thank you's on our Facebook.

His Excellency Mr Manpreet Vohra, High Commissioner of India to Australia, noted in his speech "the immense contribution made by the Indian diaspora to Australian economy and Australia society, and to our bilateral relations is deeply appreciated by all Australians. The AusIndia Fair represents the best of India's and Australia's inclusive traditions. I am happy to see this wonderful display of India's rich cultural diversity in conjunction with the multicultural ethos of Australia. Congratulations to all."

#### AIBX India Market Update

On 2 April 2022, the Government of India and Australian Government signed an interim trade agreement. Hon Piyush Goyal, Minister for Commerce and Industry, Government of India, noted the historic significance of this agreement in this letter addressed to the Indian diaspora. Further details of the agreement can be found here. FINACT has been working with relevant industry bodies to raise the awareness of this new initiative and what it means for Canberra businesses. FINACT delegates and business members attended the breakfast briefing session organised by the Austrade and the Department of Foreign Affairs and Trade (DAFT) on 22 June at QT Hotel. This was a great networking opportunity. We met with several interested groups who have expressed interest to arrange follow-up meetings with FINACT.

# 5. FINACT Sub-committee on Domestic and Family Violence

Following the approval by FINACT General Council in 2021, we now have a full-fledged team to assist with domestic and family violence matters in the community. The sub-committee consisting of following members are progressing this important task, in collaboration with other members and organisations working in this space. The sub-committee will facilitate referrals, provide information, and raise awareness to support individuals of all ages and gender, mainly focussed on the Indian diaspora affected by domestic and family violence. They will engage communities in supporting, developing, and implementing prevention strategies, under the administrative oversight of the FINACT Executive Committee, following FINACT's policies and constitution.

The Sub-committee coordinator is Dr Sunita S Dhindsa, and the members include Dr Pravati Panigrahi, Mrs Raji Samprathi, Mrs Deepti Jajee; Mrs Divya Ravikumar.

#### 6. FINACT India Centre

FINACT sub-committee consisting of Krishna Nadimpalli, Venkatesh Bidrakal, Shanti Reddy and Harjinder Dhindsa prepared a draft paper on the India Centre Business Case, which was circulated to members at the March General Council meeting. Sub-committee sought comments and suggestions from the members on the proposed steps. The sub-committee has been asked to explore options and develop a proposal for consideration. Members suggested fund-raising activities for the proposed centre to initiate the process, adopting models implemented in other states which were receiving good financial assistance from the State & Federal Governments. Members noted that there is a need for all member associations to work together to progress the implementation of India Centre. Sub-committee will continue this work in consultation with the General Council.

### 7. FINACT Webinars

#### ABS Census 2021

FINACT organised a webinar on Census 2021, delivered by ABS staff on 7 August 2021. The Q&A session following the presentation led to a good discussion on the question of ancestry and how this info should be captured

in future. FINACT will engage with ABS so that the community can provide feedback in preparing the questionnaire for the next census. ABS Census 2021 results show that ACT had the fastest population growth with 14.4% increase since 2016. Proportion of Australian residents born overseas (first- and second-generation migrants) is more than half of the total population which is notable. Number of people in the ACT of Indian ancestry has gone up from 14,483 in 2016 to 24,026 in 2021. See this ABS website for full report.

#### Remote Learning in ACT Schools

FINACT hosted a successful webinar on 21 September, discussing various aspects of remote learning and home schooling, in collaboration with the ACT Education Directorate. Mark Alliston, Kym Turnbull and Murray McKay from the Learning and Teaching branch at the ACT Education Directorate presented the webinar. They have a vast range of experience across primary, high school and tertiary education settings and have been involved with leading the ACT Education Directorate's response to COVID, including developing resources and websites for teachers and families. They've shared with the community members on how the ACT Education Directorate is helping our teachers and students during remote learning.

Smt Sheela Awadhwal, who has been teaching in the ACT for more than 20 years, provided additional information, including several valuable tips for parents, which are summarised in the FINACT Newsletter.

#### Commemoration of Victims of Mumbai Attacks

FINACT, in association with the Hindu Council of Australia, hosted a virtual Commemoration event in memory of the victims of 26/11/08 Mumbai Attacks on Friday 26 Nov 2021, 7 to 8 pm. #### Meeting with Minister Shane Rattenbury & Andrew Braddock MLA

Minister Cheyne was happy to connect us with the relevant groups/directorates so we can follow-up on these topics. Minister Cheyne was highly appreciative of FINACT's work. To quote her "I'm very impressed with the work FINACT is doing and that your efforts are as strong as ever". Thank you for your support, Minister!

Minister Cheyne updated us on the status of the Multicultural Recognition Act - Exposure Draft seeking further comments from stakeholders before the bill is presented to the Parliament. FINACT subsequently consulted members seeking community views on the proposed bill.



#### Meetings with Senator Zed Seselja

FINACT EC had a productive meeting with Senator Zed Seselja, the then Minister for International Development and the Pacific on 23 February 2021. We discussed upcoming activities - international students meet & greet, General Council meeting, International Women's Day seminar and most importantly our flagship event AusIndia Fair on 2 April. We conveyed the immediate need for a decent size community facility for celebrating multicultural events in Canberra.

#### Meetings with David Smith MP

FINACT EC had a productive, virtual meeting with David Smith MP, Member for Bean on 25 February, covering a wide range of topics including our upcoming events, key issues of interest to the community such as access to a decent size community hall for celebrating multicultural events.

### Meeting with the Executive Group Manager, ACT CSD

FINACT EC had a very productive Zoom meeting with Christine Murray, Executive Group Manager, Community Service Directorate (CSD), on 25 October 2021. We discussed a wide range of topics of community interest such as - guidance on unrecognised vaccines in Australia (which has been subsequently resolved on 1 November), extension of approved grants beyond December 2021 without impacting next round of applications due in November, community engagement in the design of proposed Community Centre, reporting mechanism to capture racism incidents, opportunity for FINACT to provide community views on the proposed Multicultural Act, and

FINACT's dedicated team which will be providing assistance to domestic and family violence victims. We will continue our engagement with CSD in a constructive and positive way, providing community inputs.

# Meeting with the ACT Discrimination, Health Services & Disability and Community Services Commissioner

FINACT, along with several ACT multicultural community leaders from Chinese, Lebanese, Bangladesh, African, Chilean and Indian background attended a meeting with Ms. Karen Toohey, the ACT Discrimination, Health Services & Disability and Community Services Commissioner, on 2 Feb 2022.

The meeting was convened by MLA Giulia Jones, the then shadow minister for Multicultural Affairs. The meeting discussed increasing reports of discrimination in Canberra, which is a concern shared by all attendees. Meeting discussed what can be done about this, how to promote awareness of citizens' rights, etc. We agreed to work with the Commissioner to raise the awareness through targeted webinars, tailored promotional materials, etc. FINACT has subsequently provided a written submission on this topic to the ACT Standing Committee.

### ABC Roundtable Meeting

Several members of FINACT General Council were invited to a roundtable meeting organised by the ABC News Canberra team led by Julie Doyle and Troy Cuthbertson, on Wednesday 8 December at Nicholls Community House.

We had a good conversation, discussed how the ABC can better serve the audience and also issues that are important to provide coverage in local news. We thank ABC for taking time to listen to suggestions to improve TV and radio of coverage of our community events. Since the meeting, FINACT members have had increased engagement and coverage of news of interest to the community.

## 9. FINACT General Council Meetings

#### First GC Meeting October 2021

FINACT hosted its first General Council (GC) Zoom meeting on 18 October. Multicultural Minister Tara Cheyne graced the meeting as the chief guest. We thank the minister for taking time to meet with member organisations. The Minister acknowledged the amazing work done by FINACT members in the past 12 to 18 months in terms of supporting the Canberra Community during the pandemic. She also briefed the audience about the upcoming Multicultural Act as well as the community centre at EPIC. Finally, she encouraged associations to apply for the Multicultural Participation Grant.

It was a great opportunity for our member organisations to interact with the Minister showcasing the depth and breadth of community services provided by FINACT member organisations covering a wide range of topics such as organising cultural events, festivals, health and sports activities, music competitions, webinars, etc.

Minister Cheyne appreciated the introductions and expressed interest in engaging with FINACT and its member organisations in future. FINACT looks forward to continuing engagement with the Minister on a number of initiatives highlighted in the meeting including the community centre.

The meeting also hosted Azra Khan, Senior Director, Dr Sally Singleton, Medical Officer and Vanessa Dal Molin, Executive Branch Manager (Exemptions) from the ACT Health Directorate as guest speakers who have provided an update on various issues related to post-lockdown strategies.

### Second GC Meeting March 2022

Second GC meeting was held on 2 March 2022 hosted at Jaga in the City. We thank Laurie Blackhall, President and Clare McGrath Vice President, Neighbourhood Watch ACT for presenting an informative session on safety and security - Be Aware, Be Safe. 
### Third GC Meeting May 2022

blood donation, encouraged the Indian community to come forward to donate blood, save lives.



## 10. FINACT Submissions

## Inquiry into Racial Vilification

FINACT has been invited to make a submission to the inquiry into racial vilification in the ACT being conducted by the Education and Community Inclusion Committee.

FINACT hosted a community consultation session on 14 June 2022. The group discussed - social and work context in which discrimination occurs, effectiveness of existing reporting mechanisms, adequacy of existing processes and practices, value of establishing Anti-racism strategy for the ACT and raise the awareness through education. FINACT its report to the Committee on 26 June 2022. It will be available from ACT website once authorised for publication.

A person who faced racial discrimination in Canberra has created the Hard Project, a platform for people to come forward and share their stories. It is dedicated to creating awareness and bringing about a social change in our multicultural society. This is a really good initiative to not only raise awareness but also do something about it. We encourage readers to look at the Hard Project and promote it.

## ACT Multicultural Recognition Bill 2022

FINACT welcomes the ACT Government's Exposure Draft Multicultural Recognition Bill 2022 for public consultation, open until 26 July.

The purpose of the Bill is to ensure that the ACT continues to grow as a welcoming, diverse, unified, and inclusive community. The Bill is set to be presented to the Legislative Assembly later this year and demonstrates a strong commitment to the vision of Canberra as a diverse and inclusive community. The Bill replaces the ACT Multicultural Framework and legislates the ACT Multicultural Advisory Council. A Multicultural Charter (Schedule 1) included in Bill describes eight principles declaring the Legislative Assembly's support to each and every individual in the ACT. FINACT organised a virtual consultation session with community members on 10 July seeking feedback on this topic. We received very good responses, including excellent

discussion on all four parts of the proposed bill. Currently drafting feedback for submission to the ACT government on 26 July.

## 11. FINACT - Other Activities

## FINACT Ten-Year Celebrations & Special souvenir

As agreed at the FINACT General Council Meeting, a document capturing FINACT achievements over the last decade has been prepared. FINACT EC acknowledges the excellent leadership of the last six presidents who have steered the organisation to become such a successful and well-respected community group in the ACT. Currently the document is being finalised for release at a special function to be organised, following discussions at the July 2022 Annual General Meeting.

## AIBC Industry Networking

FINACT attended a fantastic networking event hosted by India in Australia (High Commission of India, Canberra) Australia India Business Council Ltd promoting Defence Industry collaboration between Australia and India as many members of Indian diaspora work in this industry specialising in STEM subjects. Increased industry collaboration between the two countries is great news for all of us.

#### FINACT Job Network

Current labour market is very tight with the unemployment rate at historic lows. It is becoming increasingly difficult to find the right people for the right jobs. It is not uncommon to see job ads in the community WhatsApp groups. Despite this, temporary visa holders and students are finding it particularly difficult to find a suitable job in their respective field of study. This situation has prompted FINACT to start a new initiative to connect job seekers with employers. It is early days but we have taken small steps so far, such as creation of a WhatsApp chat group and a <u>FINACT LinkedIn business page</u> to connect with businesses. FINACT can support local businesses by connecting with potential employees from the community. We expect the next EC can take further action to promote it further and take it to a more operational

level. This initiative would also support large number of students who have finished studies, awaiting PR.

#### **FINACT Admin functions**

To run an organisation like FINACT takes a lot of behind-the-scenes administrative work. For example, during this term we -

- submitted two grant acquittals (for the years 2019-20 and 2020-21)
- created an asset register, which we expect to maintain going forward
- established Google Workspace for not-for-profit, yet to be fully operationalised
- One successful grant application approved by the ACT Govt
- Submitted a detailed proposal for consideration under the federal government "fostering integration" grants round 2022.

## Media engagement

FINACT has had considerable, productive engagement with media outlets this year with ABC 666 Radio and local TV, SBS Radio and online news, Canberra Times, Riot ACT, Mix106.3, etc. We received considerable attention in the media this year and are happy to have established a very good working relationship with the media. FINACT is seen as a default point of contact for news items relevant to the Indian community.

#### Australia celebrates India@75

FINACT works closely with the High Commission of India (HCI) on a range of issues of community interest, including celebration of India's 75th year of Independence (Azadi ka Amrit Mahotsav). The Australian Government also celebrates India@75.

FINACT supported High Commission Of India, Canberra, in organising a Bicycle Rally to celebrate India@75. It was a great day with fine weather and great company to ride around the lake with fellow Canberrans. FINACT intends to continue to work with the High Commission to organise similar events more often in future.



## India-Bangladesh Maitri Diwas

FINACT president was delighted to join 'Maitri Diwas' (Friendship Day) celebrations on 6 Dec marking the 50th anniversary of India-Bangladesh friendship.

The facility will include temple, Utsav Hall for cultural celebrations festivals or all communities, weddings and functions for rituals, Vedic Education that includes library, yoga, meditations, language classes, a large kitchen to provide free meal once a week, Vegetarian Canteen for sustained funding and parking. Currently CHM is in the Building Approval process and planning to start the construction from 5 October 2022.






