



President's Message

FINACT is an aspiring organisation, and it has immense potential to continue to serve the community. Since its inception in July 2011, FINACT has grown from a seedling to a strong tree, and it is still growing. Over the last 13 years, the environment and demographics have changed considerably and so have the community issues and needs. I have been actively involved with FINACT since 2015 and



have participated in its evolution and growth in response to the changing times to meet the needs of the Indian Australians and the broader Indian diaspora. I have been instrumental in starting and organising the AusIndia Fair, a FINACT initiative.

Over the last twelve months, leading FINACT has been very rewarding. It had been a very busy time while organising, attending, making submissions and representing FINACT. This work is reflected in the annual report, and I feel very proud of the FINACT Team, Sub committees, volunteers and performers who made it happen. Between us, we have contributed over 18,000 hours to the value of over \$1.05m in economic terms. If we add volunteer hours by member organisations for their community activities, the monetary value goes into millions. This is an example of the generosity exhibited by the community. The value of tangible and non-tangible benefits this generates for the community and broader society is above and beyond any monetary value.

FINACT has taken solid steps through its two social initiatives, Chetna and Sakhi, held two cricket tournaments, consulted with international students, engaged children through painting competition, and after one year hiatus organised Harmony Day and its signature event AusIndia Fair. These events can only be successful with community support, and I greatly appreciate that. I now have a better understanding of some challenges faced by the society and realise that they could be gradually addressed mainly through education and awareness. At the same time, I am very impressed by the talents shown by children, youth, and adults in various events.

While leading FINACT, the team has improved its fiscal status, and a term deposit of \$22,000 has been setup to support operational needs eg., insurance and sundries.

In this time, I have observed that for FINACT to be a constructive influencing force, it must stay strong to withstand pressure (internal and external), maintain its apolitical and secular presence, and continue to be an authentic voice of the Indian Australian community. It must continue to be responsive to community issues and concerns, and proactively engage with relevant stakeholders to ensure that community voice is heard, needs are met, and we are part of the decision making.

With changing demographics, the need to address requirements of the community are gaining urgency. We thank the ACT government for starting renovation of the Fitzroy Pavilion at EPIC and for allowing it to be used for community events. We are still

awaiting a multicultural centre with large capacity, and we hope that the government will see the benefit of building it. FINACT must continue to advocate to both the ACT and Federal governments to:

- Build a large multicultural centre and a large function hall to meet community needs
- Develop culturally appropriate aged care facilities and provision of culturally appropriate home support services
- Build a fully functional and resourced hospital in Gungahlin to meet the growing healthcare needs of half a million residents of the ACT and many more of the surrounding regions.

Every leader builds on the foundations laid by the previous leaders. Hence, I pay my respect to community elders whose advice and experience benefitted me and the community. I thank the past Presidents and their teams for positioning FINACT strategically. I thank all the volunteers who helped enrich FINACT over the years with their contributions.

The strength and vitality of FINACT resides in its general council. I want to thank the members for their support, trust, cooperation and engagement. It has been a privilege and a big responsibility to serve FINACT and the communities.

It has been an honour to lead the representative body of a 25,000 strong diaspora and to work with various stakeholders and the communities for the betterment of our society. With contributions and support from FINACT's sponsors, well-wishers and members, FINACT continues to be a strong voice for the people and to responsibly lead the community.

Through the FINACT team, I had the pleasure of working with dedicated individuals and together we have strengthened the position of FINACT as a responsible umbrella body. I thank them for trusting and supporting me.

I have been serving the community for the past 33 years in Australia, and I will continue while I have ability to contribute. But for now, I will pass the FINACT baton, and I am taking with me memories of many achievements and successes, some interesting challenges, and many lasting friendships.

Summary of FINACT Activities and Achievements in 2023-24

The year 2023-24 had been very busy for FINACT and its member organisations. FINACT organised many events and activities, met with stakeholders, made submissions, supported and attended events organised by members, various community organisations, ACT and federal government departments and the High Commission of India.

- Raised issues of community concern: associations' insurance, grants, after hours bus service between Canberra and Sydney airport, multicultural facility and function centre, aged care facility, India centre, and started petition for direct flight between Canberra and Delhi
- Improved fiscal status of FINACT and set up a term deposit
- 3 x General Council Meetings
- 1 x Annual General Meeting
- Raised money to establish a FINACT term deposit to pay for insurance and sundries.

The work of FINACT Executive Committee, Sub-committees and General Council amounts to more than 3000 hours of volunteer input. If we multiply it with the hourly rate of \$100 which a majority members earn, FINACT has contributed \$300,000 towards the community work. Further, 400 volunteers and performers also contributed which totals 15,025 hours and \$715,125. The total in kind contribution only from FINACT conservatively equates to approximately \$1,051,250 of economic activity and valuable community service. In addition, when we further add the hours devoted by the member organisations in their communities, the in-kind contribution by FINACT and its members rises to millions. The value of tangible and non-tangible benefits this generates for the community and broader society is above and beyond any monetary value.

The above figure highlights that the not-for-profit community organisations run by volunteers make immense contribution to the fabric of the Australian society. The governments need to take this contribution when they develop policies about value of multiculturalism and the support they can provide to the community organisations.

Our Profile

The Federation of Indian Associations of ACT Inc (FINACT) was officially launched on 31 July 2011. It is a not-for-profit, apolitical, secular community organisation run by volunteers. It is the peak umbrella body in the Australian Capital Territory (ACT) with membership of diverse organisations of Indian origin representing various aspects of the community such as regional, linguistic, youth, women, seniors, sports, culture.

It promotes advancement and integration of the Indian Australians as responsible citizens of the broader Australian society. FINACT promotes strengthening of social cohesiveness, shared values, mutual respect and harmony in the Australian society through increased participation in policy, sports, cultural, social, and recreational activities, in government initiatives, and to improve the well-being of all Australians.

FINACT provides a responsible and responsive channel of communication between the Indian Australian community and the Governments (Federal, the Territory/State and the Indian Government). We value our relationship with the government, and we develop and nurture productive working relationship with key community service organisations and non-government stakeholders in the ACT community. We value our Canberra community, and we continue to endeavour to be responsible and productive members of the community.

FINACT's Financial Health

The FINACT team has worked strategically and conservatively to manage the financials. When we started, the FINACT account balance was \$23,500 plus which included \$10,000 AusIndia Fair grant (to be expended in 2023-24). The financial status on 30 June 2024 was \$30,000 plus. From this, a term deposit of \$22,000 has been created to offset costs for operational needs such as insurance and sundries. For majority of not-for-profit community organisations run by volunteers, having enough finances to meet their operational needs is always a challenge. We are proud of setting up FINACT in a strong financial position.

Meetings with External Stakeholders

FINACT Meets with the High Commissioner of India

FINACT Executive committee (EC) Met with HE Mr Manpreet Vohra High Commissioner of India (HCI) to Australia, Nr Suneet Mehta Deputy High Commissioner and Mr Narendra Rana Councillor in his office and introduced him the new EC. President also briefed him about the upcoming FINACT activities, events and initiatives. HE appreciated the work FINACT is doing and offered support for future initiatives.

FINACT EC meets with the ACT Minister for Multicultural Affairs

FINACT EC met the ACT Minister for Multicultural Affairs Ms Tara Cheyane on 4 October 2023. FINACT team provided the history and origin of FINACT, its activities, and about its member organisations. FINACT EC has raised concerns about Chief Ministers and other Ministers not attending the Community events instead sending the advisors. Also raised the issue of suitable venues for various community events, lack of afterhours bus services to Sydney airport, grant money, National Multicultural Festival and insurance. Minister assured that she will look into these issues.

Prior to the meeting President had a pre-meeting in October 2023 with Assistant Directors of Office of the Multicultural Affairs.

FINACT EC met with the Shadow ACT Minister for Multicultural Affairs Mr Peter Cain MLA on 2 August 2023. FINACT team provided the history and origin of FINACT, its activities, and about its member organisations. Also raised the issue of suitable venues for various community events, lack of afterhours bus services to Sydney airport, grant money, National Multicultural Festival and insurance. Shadow Minister assured that he will raise these issues with the Minister.

FINACT EC meets with the Hon David Pocock Senator ACT

FINACT EC met with the Hon David Pocock Senator on 29 Sept 2023. FINACT team provided the history and origin of FINACT, its activities, and about its member organisations. Also raised the issue of suitable venues for various community events and lack of afterhours bus services to Sydney airport. Later President provided a concept diagram of a large-scale multicultural centre to Senator's office.

FINACT EC meets with the new High Commissioner of India

The new High Commissioner (HC) of India to Australia, HE Mr Gopal Baglay took office in January 2024. The FINACT Executive committee (EC) met the HC H.E. Mr. Gopal Baglay along with Deputy High commissioner Mr. Suneet Mehta and

Counsellor Ms. Sweety Agarwal at the High Commission of India office on 23 January 2024. FINACT team provided an update on history, role and activities of FINACT and about its member organisations. FINACT EC officially invited HC and HCl staff as chief guest for the FINACT Australia Day and 75th Indian Republic Day celebration on 26 January 2024. HE expressed special interest to interact with international students, seniors and community leaders of Indian diaspora.

Meeting with Mr Michael Petterson MLA

FINACT President met with Mr Michael Petterson MLA on 4 October 2023 and raised issues about suitable venues, access to grants and lack of after-hours service between Canberra and Sydney airport. FINACT thanks Mr Michael Petterson MLA for following up with Murrays Coaches regarding after hours services between Canberra and Sydney airport.

From 1 May 2024, Murrays Coaches has restored a 1.00am service from Canberra to Sydney airport.

FINACT meeting with EPIC CEO

FINACT president met with EPIC CEO Mr Matthew Elkins and his team on 24 October 2023 after meeting him at Fitzroy Pavilion Consultations on 16 October 2024. FINACT raised the concern about Event spaces, EPIC not entertaining FINACT members and booked Fitzroy Pavilion for AusIndia Fair.

In partnership with Rotary Club and Fair Canberra, FINACT successfully celebrated Australia Day and 75th Indian Republic Day at Margaret Hendry School Hall in Taylor, on 26 January 2024. The event was graced by many dignitaries including H.E. A highlight of the event was the display of over 50 impressive artworks submitted by children, depicting what Australia Day means to them. The event also featured Indian and Australian cultural performances and concluded with a mouthwatering BBQ hosted by the Rotary Club Ginninderra and Indian snacks by Indian Pantry, Florey.



National Multicultural Festival 2024

FINACT had an information stall at the National Multicultural Festival (NMF) which was held on 18 Feb 2024. Free henna tattoo, sari draping demonstration and Indian literature books were on display. Henna tattoos done by a professional henna artist attracted many people, mostly youngsters, from various cultural backgrounds and was a huge success, with a room full of people wanting to apply henna on their hands. Sari draping demonstration was a women-focused event and promoted community interaction on cultural diversity and provided a valuable networking opportunity. With many participants from non-Indian backgrounds, the activity offered new cultural experiences and insights into India's traditional attire. A variety of saris from different regions of India were on display for browsing. The demonstration attracted women of all ages, sparking interest among the younger generation in wearing saris and other Indian accessories.

Chetna, The Power of Perception: A Social Initiative

Chetna is a FINACT initiative to raise awareness about and promote prevention of domestic and family violence in the Indian Australian population in the ACT region. It promotes domestic abuse awareness and culturally inclined early intervention through focusing on relationship dynamics in a family setting which includes all genders.

The Chetna sub-committee's new team for 2023 created activities focused on an innovative and culturally sensitive family based primary prevention model.

Daughter and Dad: Prevention & Awareness Event Series

Chetna's inaugural awareness event, Daughter and Dad, was launched on 2nd June 2024 at Bristol Clubhouse, Kaleen. The event focused on fostering self-reflection and understanding relationship dynamics at home, emphasising their impact on future generations. The awareness activities included customized theatre performances and quizzes, designed to encourage self-reflection.

Held in partnership with Migrant and Refugee Settlement Services (MARSS) and led by Chetna volunteers, the event saw attendance from many dad-and-daughter pairs, families, frontline community workers, and staff from MARSS and the Domestic Violence Crisis Support services. MCed by a Radio Manpasand Dad and Daughter duo, participants engaged in various sessions, including discussions, quizzes, role play by a Dad and Daughter duo from Perform Australia, relaxation workshop by Art of Living, and a Bollywood workshop. The celebrations included honouring the participants and the sponsors.





Let's Learn Together: Workshop Series by Chetna

Chetna's workshop on positive relationships was held on 23rd June 2024 at Bristol Clubhouse, Kaleen in partnership with Migrant and Refugee Settlement Services. It was a follow up to the Dad and Daughter event to enable in-depth discussion and understanding.

This was achieved through two presentations on domestic and family violence drivers in migrant communities and an Art of Living workshop. This platform allowed for reflection and discussion on real-time community case scenarios and suggestions for productive solutions.

Sakhi

Sakhi was set up in July 2023 to support women of the Indian community, and over the space of one year, has obtained two community grants and ran five events with the last one held on 21st July 2024.

Events have included those held to celebrate Mothers Day and International Womens Day, as well as mental health month and a workshop on women's safety. These were attended by more than 350 women overall. In collaboration with ICSA, Sakhi also held a workshop on first responder training for women experiencing domestic and family violence. Sixteen women received training in the first workshop.

It has proven to be a highly successful platform to support women, especially those who are new to Canberra, and has been able to engage members from almost all Indian associations in the ACT.

Since its inception, Sakhi has organised several successful events and training programs, including:

- Mental Health Awareness in October 2023
- DFV First Responders' Training in February 2024
- International Women's Day Celebration in March 2024
- Mother's Day Celebration in May 2024
- Suraksha Women's Safety in July 2024

Sakhi continues to stand out as a highly successful platform for supporting women, particularly newcomers to Canberra, by engaging members from various organisations across the ACT. FINACT Constitution Review Subcommitee

The FINACT constitution is a dynamic guide which has continued to evolve to reflect the changing times and FINACT's activities. To review the constitution as special purpose constitution review subcommittee was formed by the General Council. This special purpose subcommittee was formed by the General Council in the first GCM 2022-23 and was reapproved in first GCM of 2023-24.

The sub committee put in many hours of work to amend the constitution to bring it in line with current FINACT operations and new model rules requirements issued by the ACT government. The amended constitution was circulated to members on 1 July 2024 for consultation and constructive feedback in accordance with the current Constitution guidelines. Constructive feedback provided by some members were incorporated in the amended constitution. The constitution will be presented for adoption at the AGM to be held on 27 July 2024.



Lobbying for Suitable Venue for Community Use
